HOW TO REGISTER:

You must create your account by providing your full name, email address, cell number, CNIC/NICOP number, and a password. <u>Please double-check your email address for any typos</u>. If you enter an incorrect email address during registration, you will not be allowed to register again with the same name and CNIC/NICOP number. <u>To avoid any issues</u>, please take this first step very carefully.

HOW TO SUBMIT THE APPLICATION FORM.

Applications must be submitted using the prescribed form available on the LUMS-MoC Written Test portal at <u>https://moc.lums.edu.pk/</u>. Applications in any format other than the online application form will not be accepted.

The deadline for submitting the online application is <u>midnight on December 15, 2024</u>. However, it is advisable not to wait until the last minute to submit your application, as the system may become overburdened or malfunction unexpectedly. Please note that the system will not accept any applications after the deadline, and incomplete applications will not be considered.

In the application form, you are required to provide important details, including the position you are applying for, and personal information such as your name, father's/husband's name, gender, marital status, date of birth, nationality, CNIC/NICOP number, residential address, academic background, occupational group, professional experience, language proficiency, and name of dependents, etc.

Printed copies of the submitted online form, along with the required documents, must be received by the LUMS Written Test Team within fifteen (15) days of the advertisement date. Incomplete or late applications will not be considered.
